CLOSING DATE: FRIDAY 28th FEBRUAY 2025 AT 12.00 MIDNIGHT PACJA (Pan African Climate Justice Alliance) is a Consortium of more than 2000 organizations from 54 African countries, and brings together a diverse membership drawn from Faith-based Organizations, Community-based organizations, non-Governmental organizations, Trusts, Foundations, Indigenous Communities, Farmers, women movements youth groups and Pastoralist Groups with a shared vision to advance a people-centered, rights-based, equitable, just and inclusive approach to climate action.

### 1. POINT OF CONTACT

Suppliers are asked to provide a single point of contact; this contact will be considered the sole spokesperson for the supplier during the PQQ process.

### 2. EVALUATION CRITERIA OF PQQ RESPONSES

The objective of the PQQ evaluation is to assess the responses and select potential suppliers for the next stages of the procurement process. *PACJA wishes to ascertain:* 

- a) **Supplier capability**-the supplier must have appropriate expertise and guaranteed capacity to meet the PACJA specification.
- **b) Supplier track record-the** supplier must be able to demonstrate a successful track record of providing services similar to those required by PACJA.
- **C**) **Financial standing** –the supplier must be considered financially sound.

### The specification criteria to be considered at the selection stage include:

- ◆ Physical location
- ◆ Specialist skills and competencies
- ◆ Compliance with Regulatory Authorities
- ♦ Membership of professional bodies where applicable
- ◆ Quality accreditation
- Comparable work assignments completed with details of output and result (references)
- ◆ Contract performance and result (reference)

Prospective bidders will not be considered qualified unless in the sole judgment of the Panafrican Climate Justice Alliance who will determine, according to their discretion, the qualifications of prospective bidders to satisfactorily execute the contract for services.

If question is insufficiently or incorrectly answered or are completely unanswered then the likelihood of being included in the qualification phase is reduced.
